## Preface

## by Amb. Dore Gold

The International Criminal Court (ICC) has returned as a central issue of debate in American foreign policy. But the debate this time not only influences American interests but also the interests of its key allies, especially Israel. In March, 2019, Secretary of State Mike Pompeo warned that Washington would impose restrictions on any ICC staff member who investigated U.S. or allied personnel.

This past October, the State Department revoked the U.S. visa of Fatou Bensouda, the ICC's Chief Prosecutor, after she declared her intention to conduct an investigation of U.S. soldiers in Afghanistan. In March 2020, she authorized an investigation into alleged war crimes committed in Afghanistan since 2003. This included members of the CIA and U.S. military forces.

Since the ICC was created in 1998 through an international treaty, known as the Rome Statute, the U.S. has been highly ambivalent about the court. The Western powers further empowered the ICC in the aftermath of the UN's failure to prevent genocide during 1994 and 1995, with the slaughter of 8,000 Bosnian Muslims in Srebrenica during the Balkan Wars, and the mass murder of 800,000 members of the Tutsi tribe in Rwanda by that country's Hutu majority. The ICC was established amidst growing calls to put an end to impunity for those who engaged in the mass slaughter of civilians or ethnic cleansing as well as other heinous acts.

While President Bill Clinton did sign the Rome Statute in 2000, he did not send it to the U.S. Senate for ratification, which would have been necessary for it to become a binding commitment of the United States. In 2002, the Bush administration took this one step further, notifying the UN Secretary General that the U.S. no longer had any intention of ratifying the Rome Statute.

The ICC is based on the principle of complementarity—that is, it only has jurisdiction if an alleged crime occurred in a state that has no effective legal system to prosecute it, due to a lack of capacity or political will. Nonetheless, American critics of the court rightfully are concerned that the ICC could be abused so that warrants could be issued to drag American military personnel in front of the court, regardless of the fact that the U.S. military has its own system for investigating allegations of military misconduct.

Israel's concerns have been similar to those of the U.S. These concerns stem from Israel's bad experience with multilateral institutions in the past that have made

baseless allegations against IDF soldiers to the effect that they engaged in war crimes. The UN Human Rights Council issued the Goldstone Report in 2009 asserting that Israeli soldiers deliberately killed Palestinian civilians in Gaza. Subsequently, Justice Goldstone renounced this central conclusion contained in his own report. But the experience served as a warning of how international investigations can be abused and colored by the prejudices of those involved.

The U.S. has been cognizant of the dangers that an abused ICC could pose for Israel. U.S. law prohibits economic support for the PA if it prompts a process that places Israelis under an ICC investigation. Such an initiative would also provide grounds for closing the PLO's Washington offices as well, which occurred in September 2018.

Both the U.S. and Israel have been concerned with the politicization of the ICC. At the time of the vote for the Rome Statute, the head of the Israeli delegation, Judge Eli Nathan, explained how politicization of the ICC's founding document caused Israel, a proponent of the court, to vote against it. Nathan, who was a Holocaust survivor, spoke about leading Jewish legal minds who, after the Holocaust, called for bringing war criminals to justice. He saw the ICC emanating from Jewish ethics, and concluded: "This was...our idea."

But the Rome Statute went beyond the most heinous crimes like genocide, aggression, war crimes, and crimes against humanity, and gave the ICC jurisdiction on political issues like settlements. Plenty of third world countries backed this change, but it was inconsistent with what the original drafters had in mind.

In 1998, during discussions over the text of the Rome Statute, the issue raised was settlements, but the debate between states over the ICC illustrated that any legal issue might be weaponized and converted into a political assault against America and Israel by using the mechanism of the ICC. The U.S. has been aware of this problem, which explains why, like Israel, it could not back what started as a noble cause but later became a seriously flawed idea.

This paper describes one aspect of the politicization of ICC - how radical NGOs, some of which are affiliated with terror organizations, collaborated in filing official complaints against the United States and Israel.

Ambassador Dore Gold has served as President of the Jerusalem Center for Public Affairs since 2000. From June 2015 until October 2016 he served as Director-General of the Israel Ministry of Foreign Affairs. ## **Executive Summary**

Fatou Bensouda, the Chief Prosecutor for the International Criminal Court (ICC), has undertaken efforts to launch two simultaneous investigations of alleged crimes against humanity: One against the United States, for crimes it allegedly carried out in Afghanistan, and another against Israel, for crimes it purportedly committed in the Palestinian Authority controlled territories, which the prosecutor is ready to consider as the "state of Palestine," though such a state does not exist.

What is notable about these parallel efforts by the ICC to investigate both the United States and Israel is that the NGOs and individuals pursuing both cases are closely related. The two international NGOs advancing the case against the US, the International Federation for Human Rights (FIDH) and the Center for Constitutional Rights (CCR), are closely related to the Palestinian NGOs that brought the complaint against Israel to the ICC (AI-Haq, Palestinian Center for Human Rights, AI Mezan and AI-Dameer) and were intimately involved in their submissions to the court.

The above referenced complainant organizations to the ICC against Israel and the United States - Al-Haq, Al-Dameer, Al Mezan and the Palestinian Center for Human Rights - maintain strong ties to the designated terror organizations Hamas and the Popular Front for the Liberation of Palestine (PFLP), according to a report

published in 2019 by the Israeli government.<sup>1</sup> They are far from being human rights organizations as they have falsely represented themselves, as they maintain close ties to terror organizations designated by US State Department and the European Union. For example, Shawan Jabarin, Executive Director of Al-Haq since 2006, is a former senior operative of the Popular Front for the Liberation of Palestine and has served multiple prison sentences for his terror affiliated activity.<sup>2</sup> Israel's Supreme Court called Jabarin "Dr. Jekyl and Mr. Hyde" for his simultaneous terror-affiliated activity and his leadership of the Al-Haq "Human Rights" group.<sup>3</sup> In May 2018, Visa, Mastercard, and American Express shut down online credit card donations to Al-Haq due to the group's ties to the PFLP. Shawan Jabarin has been denied exit visas by Israel and Jordan.<sup>4</sup> Leaders of the other Palestinian terror groups. They have been active in working against US policy in the Middle East, condemning the US Administration's declarations regarding the Golan Heights, Jerusalem and the Jordan Valley.

It is not only that AI-Haq, PCHR and AI Mezan are members of FIDH, but AI-Haq's director, Shawan Jabarin, is the secretary general of FIDH. Moreover, Raji Sourani, the general director of PCHR, is the former vice president of FIDH. Nada Kiswanson van Hooydonk and Katherine Gallagher, who represented the victims, FIDH and CCR in the case against the US, were also engaged with the Palestinian submission. Kiswanson was the head of AI-Haq's office in The Hague, and Gallagher, who represents CCR in the Afghanistan case, was part of the delegation that submitted the Palestinian NGOs' opinion to the ICC prosecutor.

It should be noted that CCR and FIDH are also deeply involved in other legal aspects of anti-Israel activities, including boycott, sanctions, and divestment (BDS) initiatives, and that the four Palestinian NGOs that filed the complaint to the ICC have close relationships with terror organizations designated by the European Union and the US State Department, especially with the PFLP. As noted above, Shawan Jabarin was convicted of terror activities in the PFLP and imprisoned for three years.<sup>5</sup>

Moreover, the impartiality of ICC prosecutor Bensouda in those cases is doubtful due to the special nature of her relations with FIDH. In the past few years FIDH and Bensouda have maintained close ties, as described on FIDH's website, as a "close relationship with the Court."<sup>6</sup> In 2015, Bensouda visited FIDH's headquarters in Paris, and in 2019, she participated in FIDH's 40th Congress as one of the main speakers.<sup>7</sup>

It may come as little surprise that, according to Jordanian sources, the prosecutor hinted to the Palestinians that the entire process of her conducting a preliminary examination as to whether the court has the authority to proceed with investigating the case against Israel was meant only to protect the court from criticism, while she had already decided to move the case forward.<sup>8</sup>

In short, the particularly close relationships between the accusing organizations in both cases reveal the politicized nature of these complaints. Moreover, the overlapping connections between the Palestinian NGOs and terror groups and between Bensouda and FIDH raise serious questions about objectivity and intent.

## Background

On March 5, 2020, the International Criminal Court (ICC) Chief Prosecutor, Fatou Bensouda, authorized the opening of an investigation into alleged war crimes and crimes against humanity committed in Afghanistan since 2003 by members of Afghan and foreign forces, including the Central Intelligence Agency (CIA) and US military forces.<sup>9</sup>

This decision was met with severe criticism from US Secretary of State Mike Pompeo, who described the ICC as an "unaccountable political institution, masquerading as a legal body."<sup>10</sup>

The decision appears to be the result of a joint operation conducted by various international legal organizations that pressured the ICC into investigating the situation in Afghanistan, and specifically the United States. A cause of particular concern is the correlation between this investigation and the ICC investigation against Israel; indeed, the same key people and organizations are involved in both cases.



## **US-Afghanistan case**

In April 2017, the International Federation for Human Rights (FIDH), the Center for Constitutional rights (CCR) and other international organizations called on the ICC to investigate the situation in Afghanistan.<sup>11</sup> This call followed a FIDH delegation to The Hague (April 3-7, 2017), composed of Afghan civil society groups and US activists, who met with representatives of the ICC in order to demand accountability for the situation in Afghanistan.<sup>12</sup> Seven months later, in November 2017, the ICC prosecutor requested to initiate an investigation into alleged war crimes and crimes against humanity in relation to the armed conflict in Afghanistan.<sup>13</sup>

However, two years later, in April 2019, the ICC Pre-Trial Chamber rejected the prosecutor's request.<sup>14</sup> Following that decision, CCR and other legal representatives increased their pressure and filed the Victims' Notice of Appeal.<sup>15</sup> After a protracted process of submissions,<sup>16</sup> appeals<sup>17</sup> and hearings,<sup>18</sup> the ICC eventually reversed the Pre-Trial Chamber decision and authorized a full investigation of crimes in and related to Afghanistan in March 2020.<sup>19</sup>

## Key Players Behind the US Investigation

### International Federation for Human Rights (FIDH)

FIDH is a France-based international non-profit umbrella organization founded in 1922 and consists of 184 human rights organization from 112 countries.<sup>20</sup> FIDH focuses on litigation, advocacy and providing support to local human rights member organizations.<sup>21</sup> Moreover, it actively takes part in research on alleged human rights violations and lobbying of national and international official governmental bodies.<sup>22</sup> Due to FIDH's extensive connections and influence, in some cases its actions have succeeded in bringing about divestment from Israel or, at the very least, international pressure.<sup>23</sup> Since 2004, FIDH had maintained a permanent Haguebased representation to the ICC that facilitates various interactions.<sup>24</sup>

In the past few years it seems that FIDH and the ICC Chief Prosecutor, Fatou Bensouda, have maintained close ties, in what was described on FIDH's website as a "close relationship with the Court."<sup>25</sup> In 2015, Bensouda visited FIDH's headquarters in Paris, and in 2019, she participated in FIDH's 40th Congress as one of the main speakers.<sup>26</sup>

## Center for Constitutional Rights (CCR)

CCR is a 501(c)3 non-profit legal and educational organization founded in New York in 1996.<sup>27</sup> CCR is committed to "dismantling systems of oppression and fighting for justice through litigation, advocacy, and narrative shifting."<sup>28</sup>

The organization is highly involved in lawfare campaigns targeting the State of Israel, such as filing lawsuits against Israeli officials<sup>29</sup> and US-based companies cooperating with Israel.<sup>30</sup> Moreover, it takes an active role in attempts to counter or overturn anti-BDS legislation in the US,<sup>31</sup> organizing delegations<sup>32</sup> and portraying Israel's actions as "the genocide of the Palestinian people."<sup>33</sup> Furthermore, in 2019, the Jewish National Fund (KKL-JNF) filed a lawsuit against the organization US Campaign for Palestinian Rights (USCPR), which is legally represented by CCR,<sup>34</sup> for conspiring to provide financial aid to designated terrorist organizations such as Hamas. It also claimed that USCPR materially supported the launch of incendiary terror balloons and kites launched from Gaza into Israel as well as actively promoting and sponsoring the "Stop JNF Campaign" aimed specifically at targeting and harming KKL-JNF.<sup>35</sup>

### **Katherine Gallagher**

Katherine Gallagher is a human rights attorney who is a senior staff attorney at CCR and also served as the vice president of the International Board of FIDH.<sup>36</sup> Gallagher has been highly involved in the Afghanistan case,<sup>37</sup> supports it publicly,<sup>38</sup> promotes it in her role at CCR,<sup>39</sup> and calls for the ICC "to hold the US accountable for crimes in Afghanistan."<sup>40</sup> On January 31, 2018, CCR submitted a case to the ICC concerning two men detained at Guantanamo, in support of the Afghanistan case. Currently, Gallagher serves as victims' representative in the Afghanistan case.<sup>41</sup>

### Nada Kiswanson

Nada Kiswanson van Hooydonk is a Swedish-Palestinian lawyer<sup>42</sup> who serves as the legal representatives of victims in the Afghanistan case.<sup>43</sup> She has worked for many years for Al-Haq and was the director of its European offices in The Hague and Brussels.<sup>44</sup> The offices were strategically located next to the European Parliament headquarters<sup>45</sup> and the International Criminal Court.<sup>46</sup>

## Correlation with the ICC Investigation Against Israel

On December 20, 2019, the International Criminal Court prosecutor, Fatou Bensouda, announced that there existed sufficient evidence to begin investigating "war crimes" allegedly committed by Israel in the West Bank, East Jerusalem and Gaza.<sup>47</sup>

This decision was a result of an ongoing lawfare campaign organized and coordinated by four Palestinian organizations: Al-Haq, Al-Dameer, Al Mezan and the Palestinian Center for Human Rights, which hold strong ties to the designated terror organizations Hamas and the Popular Front for the Liberation of Palestine (PFLP).<sup>48</sup>

The four organizations submitted six reports to the ICC between 2015 and 2018. Katherine Gallagher and Nada Kiswanson, both significant players in the Afghanistan case, were also heavily involved in the Israel case.

In preparation for the first submission, Al-Haq opened an office in The Hague, where the Office of the Prosecutor is located,<sup>49</sup> and appointed Kiswanson to be its representative there.<sup>50</sup> Al-Haq's office enabled it to speedily submit reports and conduct lawfare with unfettered access to the highest international legal bodies.

Kiswanson and Gallagher both attended the handing over of the first submission in 2015 along with Al-Haq representative Shawan Jabarin.<sup>51</sup>

Gallagher also attended the third submission, of a 145-page file on the Israeli closure of the Gaza Strip in 2016.<sup>52</sup> Kiswanson, along with Jabarin, filed the fourth submission on alleged crimes committed by Israel in the West Bank and East Jerusalem in 2017.<sup>53</sup>

Currently, Gallagher serves as the legal representative of victims in the Palestine case, and on March 16, 2020, she submitted the victims' observation to the ICC Pre-Trial Chamber.<sup>54</sup>

Moreover, on April 13, 2020, during a webinar on the "Israel-Palestine at the International Criminal Court," Gallagher was quoted as saying "the way the United States is treating the ICC both to protect its own and to protect Israeli officials is the way dictatorships operate" (01:00:23).<sup>55</sup>

In addition, AI-Haq, PCHR and AI Mezan, three of the four terror-affiliated organizations involved in the Israeli investigation, are coalition members of FIDH,<sup>56</sup> which led the Afghanistan case. FIDH promotes a one-sided agenda regarding the Israeli-Palestinian conflict, utilizing various measures such as involvement in CSR (Corporate Social Responsibility) in an attempt to inflict financial harm on Israel.<sup>57</sup> Moreover, it seems that members of these three Palestinian NGOs hold significant positions in FIDH, such as Shawan Jabarin, AI-Haq's Director General,<sup>58</sup> who currently serves as the secretary general of FIDH,<sup>59</sup> and Raji Sourani, PCHR's Director General, who served as vice president of FIDH.

Additionally, CCR is a coalition member of FIDH<sup>61</sup> and has supported the ICC investigation of Israel.<sup>62</sup>

CCR also hosted both Jabarin and Sourani on an advocacy mission in the US in 2016, during which they met with its executive director, Vincent Warren.<sup>63</sup>

### Government Funding of the ICC Submissions

In the years 2015-2018, in which six reports against Israel were submitted to the ICC by four terror-affiliated Palestinian NGOs, several governments and government agencies provided the NGOs with financial support, with some directly financing the submissions against Israel.

#### USAID

The United States Agency for International Development donated a total amount of \$394,500 to AI-Dameer in 2009-2018.64

#### The European Union (EU)

The EU donated €296,600 to Al-Haq and €449,997 to Al Mezan in 2018.<sup>65</sup> In 2016, Al-Dameer and the Palestinian Non-Governmental Organizations Network (PNGO) received a joint grant of €446,482 from the European Union titled "contributing to the respect, protection and promotion of the right to association in the Gaza Strip."<sup>66</sup> Moreover, the EU provided PCHR with a three-year grant (2019-2021) of €320,187 to support training courses in Gaza.<sup>67</sup>

#### UNDP

In 2014-2017 Al-Haq, Al Mezan and Al-Dameer received financial support from the UN Development Program joint project "Sawasya: Strengthening the Rule of Law in the oPt: Justice & Security to the Palestinian People."<sup>68</sup> The project is funded by the UNDP, the Netherlands, the United Kingdom Department for International Development (DFID), the European Union and the Swedish International Development Cooperation Agency (SIDA).<sup>69</sup> In 2016, Sawasya launched a partnership with Al Mezan, Al-Dameer and Al-Haq, in order to develop case files and investigations, culminating in the submission of a file to the prosecutor at the International Criminal Court.<sup>70</sup>

#### Ireland

Irish Aid, the Irish government's program for overseas development,<sup>71</sup> donated  $\in 80,000$  to AI-Haq in 2016,<sup>72</sup> 2017<sup>73</sup> and 2018.<sup>74</sup> It also granted PCHR the same amount in 2016<sup>75</sup> and 2017.<sup>76</sup>

#### Spain

The Spanish Agency for International Development Cooperation (AECID), which is attached to the Spanish Ministry of Foreign Affairs and Cooperation,<sup>77</sup> provided a joint grant of  $\leq$ 324,025 to both Al-Haq and the Palestinian Centre for Human Rights in 2016 for a period of 18 months.<sup>78</sup>

It also donated €250,000 to PCHR in 2017 for supporting "Justice, women and gender-based violence in Gaza."  $^{79}$ 

#### Norway

According to the Norwegian Agency for Development Cooperation (NORAD), a directorate under the Norwegian Ministry of Foreign Affairs,<sup>80</sup> Al-Haq received \$193,738 (2,000,000 NOK) in 2017.<sup>81</sup>

In addition, Al Mezan received \$95,089 (1,000,000 NOK) in 2015-2016.<sup>82</sup> Al Mezan is a partner of a joint project funded by the Norwegian government via Save the Children Norway (Redd Barna Norge), aimed at monitoring child rights in Palestine and reporting to the UN Committee on the Rights of the Child. This project received \$1,173,303 (12,339,000 NOK) in 2016 and \$1,107,977 (11,652,000 NOK) in 2018.<sup>83</sup>

## **Al-Haq** "Law in the service of man"



### Main Findings

Al-Haq is a self-declared human rights organization which has global connections and a far-reaching influence. Using its status among international legal bodies, Al-Haq provides legal justification for the delegitimization campaigns against the State of Israel.

Al-Haq's staff is closely tied to the US-designated terror organization the Popular Front for the Liberation of Palestine (PFLP).

By partnering with other coalitions and organizations in the BDS network, Al-Haq manages to maintain and improve its status as a leading figure in the ongoing anti-Israel lawfare

### Background

Al-Haq is a Palestinian NGO based in Ramallah that claims to promote human rights and the rule of law in the Palestinian Authority.<sup>88</sup> The organization was founded in 1979, and describe itself as "one of the first human rights NGOs in the Arab world".<sup>89</sup> Registered in the Palestinian Ministry of Justice (RA-2283-LS),<sup>90</sup> Al-Haq is the West Bank affiliate of the International Commission of Jurists (Geneva), a member of the World Organization Against Torture (OMCT) and also holds a special consultative status with the UN Economic and Social Council (ECOSOC).<sup>91</sup>

The bulk of Al-Haq's work focuses on legal actions against the State of Israel on both regional and International levels such as in the UN<sup>92</sup> and the ICC.<sup>93</sup> This includes conducting research and reports on the involvement of international companies in Israel,<sup>94</sup> documenting alleged violations of Palestinian human rights,<sup>95</sup> obtaining arrest warrants against Israeli officials such as Tzipi Livni<sup>96</sup> and Ehud Barak,<sup>97</sup> launching advocacy missions briefing official policy-makers,<sup>98</sup> and providing evidential materials for international lawsuits against the State of Israel.<sup>99</sup>

#### **Endorsement of the BDS Movement**

Al-Haq's representatives participated in the 2001 Durban World Conference against Racism, Racial Discrimination, Xenophobia and Related Intolerance,<sup>100</sup> where the foundations and framework of the Boycott, Divestment and Sanctions (BDS) Movement were established.<sup>101</sup> Moreover, Al-Haq's General Director, Shawan Jabarin, declared that "Al-Haq principally support BDS as a non-violent campaign" and "banning and boycott will bring us closer to ending the occupation."<sup>102</sup>

The organization plays a key role in the BDS campaigns against the State of Israel by cooperating with other organizations in the BDS network,<sup>103</sup> and by providing legal documentation to justify those campaigns.<sup>104</sup>

### **Al-Haq's Connection to Terror**

One of Al-Haq's self-assigned missions is to "promote the rule of law and respect for human rights."<sup>105</sup> At the same time, some Al-Haq staff members, including its Executive Director, have strong ties to the Popular Front for the Liberation of Palestine (PFLP), a designated terror organization in the United States,<sup>106</sup> EU,<sup>107</sup> Israel<sup>108</sup> and Canada.<sup>109</sup>

#### Shawan Rateb Jabarin (Director General)



Shawan In 1985, Jabarin was convicted for recruiting and arranging training for members of the PFLP. He was arrested several times between 1992-1994 and was placed in administrative detention.<sup>110</sup> An Israeli statement to the UN noted that he "had not discontinued his terrorist involvement and maintains his position in the leadership of the PFLP."

According to an article published by the Al-Quds newspaper, Jabarin spoke at a PFLP event on behalf of the organization in 1999.<sup>112</sup> Furthermore, Jabarin has been denied exit visas by both Israel and Jordan several times.<sup>113</sup>

Even though Jabarin denies ties to the PFLP,<sup>114</sup> the Israeli Supreme Court described him as "Dr Jekyll and Mr. Hyde" for his dual role as a director of a human right organization on the one hand, and a leading figure in a designated terror organization on the other.<sup>115</sup> In an Israeli governmental report revealing ties between BDS NGOs and terror organizations, Shawan is described as a senior PFLP member.<sup>116</sup>



Suha Jarrar has worked at Al-Haq as an Environmental policy researcher since 2017.<sup>123</sup> Her mother, Khalida Jarrar, is a member of the PFLP,<sup>124</sup> and has been arrested numerous times by the Israeli authorities. Khalida was released in March 2019 after spending twenty months in administrative detention.<sup>125</sup>

Following her release, Ismail Haniyeh, head of the Hamas' Political Bureau, called Khalida to congratulate her.<sup>126</sup> The U.S. Department of State has classified Hamas as

#### Manaf Abbas



Manaf Abbas is the visual documentation coordinator at Al-Haq.<sup>130</sup> In August 2019, Abbas mourned the death of two Hezbollah members, Hassan Zeinab and Yasser Ahmed Taher, on his Facebook profile, describing them as "martyrs."<sup>131</sup> Hezbollah is a designated terror organization in the United States,<sup>132</sup> EU,<sup>133</sup> Israel,<sup>134</sup> Argentina<sup>135</sup> and Canada.<sup>136</sup>

#### Ziad Hamidan

Ziad Hamidan is the head of training and capacity building unit at Al-Haq.<sup>137</sup> In 2002, Israel refused to authorize Hamidan to travel to a conference in Madrid.<sup>138</sup> Additionally, Ziad has shown support on social media for the death of Rabah Muhanna, a PFLP leader in Gaza.<sup>139</sup>

#### **Public Support for Terrorists**

In 2001 Al-Hag supported the release of its former staff member,<sup>140</sup> attorney Daoud Darawi, after for he was arrested his connections to the Palestinian Islamic Jihad and the **PFLP**, 141 both designated terror organizations in the United States,<sup>142</sup> EU,<sup>143</sup> Israel<sup>144</sup> and Canada.<sup>145</sup> Darawi was also on the PFLP list for 2005 Palestinian the parliamentary elections.146 During the second Intifada in 2002, Al-Hag offices were raided by the IDF.147

### **Al-Haq's Global Influence**

In 2009, Al-Haq founded the Center for Applied International Law, which aims to research, educate and train activists and students in order to influence decision making on national and international levels.<sup>148</sup> This center hosts seminars, workshops, internships, summer schools, delegation (of student groups and diplomats) and conferences on international humanitarian law and human rights.<sup>149</sup> It claims to be the first center in the Palestinian Authority that specializes in the practical application of international law.<sup>150</sup> This center helps Al-Haq to gain global reach and recognition among the academic, legal and political communities.

#### **Partnerships and Coalitions**

Al-Haq is a member of numerous local and international coalitions supporting the BDS Movement, which allows it to expand its collaborations and reach worldwide.<sup>151</sup>

Al-Haq is a member of the Palestinian Non-Governmental Organizations Network (PNGO), an umbrella organization of Palestinian NGOs that are based in the West Bank, Israel and Gaza.<sup>152</sup> Al-Haq is also member of the Civic Coalition for Palestinian Rights in Jerusalem (CCPRJ).<sup>153</sup> Both PNGO and CCPRJ are members of the BDS National Committee (BNC).<sup>154</sup> Moreover, Al-Haq is a member of the Palestinian Human Rights Organizations Council (PHROC), a coalition of several Palestinian NGOs<sup>155</sup> supporting the BDS Movement.<sup>156</sup>

Al-Haq is also a member of International Federation for Human Rights (FIDH), a federation of 184 human rights organizations from around the world<sup>157</sup> supporting the BDS Movement.<sup>158</sup> Both organizations are members of the EuroMed Rights Network (EMRN),<sup>159</sup> a network of more than 80 human rights organizations,<sup>160</sup> among them

BDS-supporting groups Human Rights Watch,<sup>161</sup> Amnesty International<sup>162</sup> and the Cairo Institute for Human Rights Studies (CIHRS).<sup>163</sup>

#### Labor Unions

In the past few years, Al-Haq has tried to apply pressure on unions around Europe in order to encourage divestment from Israeli companies<sup>164</sup> and the boycott of Israeli goods.<sup>165</sup> By partnering with unions in various European countries, Al-Haq has managed to pressure governments and state-owned companies to put an end to involvement with Israel and in some cases to support the BDS Movement.<sup>166</sup>

For example, in 2009, a delegation of 11 trade unionists from the Scottish Trade Union Congress (STUC) visited Israel and the Palestinian Authority. The delegation was followed by STUC's decision to consider supporting the call for boycott, disinvestment and sanctions against Israel. After meeting with officials from Al-Haq, the Stop the Wall Campaign and the Palestinian Academic Boycott of Israel (PACBI), STUC decided to officially support the BDS Movement.<sup>167</sup>

In addition, in May 2015, Al-Haq, along with French NGOs and two French unions – the General Confederation of Labor (CGT) and the Union Syndicale Solidaires – which both support the BDS Movement,<sup>168</sup> published a report about the involvement of Orange S.A. (formerly France Télécom S.A.) with the Israeli telecommunication company Partner.<sup>169</sup> This report was published as part of the "Made in Illegality" campaign,<sup>170</sup> designed to pressure officials in Belgium, France and the EU to "stop supporting the settlements

economy."<sup>171</sup> Al-Haq and Solidaires Unitaires Démocratiques (another French union) are members in this campaign.<sup>172</sup> Following the release of the report, Orange's CEO announced that his company would terminate its contract with Partner.<sup>173</sup>

In addition, in March 2017 Al-Haq, together with French unions CGT, Union Syndicale Solidaires and other French NGOs, issued a report demanding that French banks withdraw all direct or indirect funding from Israeli banks and companies facilitating Israeli settlements.<sup>174</sup>

Moreover, Shawan Jabarin, Director General of Al-Haq, visited Norway in April 2017 where he warned of "the risk of Israeli annexation of Palestine."<sup>175</sup> During his visit, Jabarin met with representatives from the Norwegian Union of Municipal and General Employees (Fagforbundet),<sup>176</sup> the largest union in the Norwegian Confederation of Trade Unions (LO).<sup>177</sup> A month later, on May 12, the Norwegian Confederation of Trade Unions endorsed a full "international economic, cultural and academic boycott of Israel."<sup>178</sup>

In addition, in 2018 French unions CGT, Union Syndicale Solidaires, the French Democratic Confederation of Labour (CFDT) along with other French NGOs and Al-Haq published a report about the involvement of French companies in the construction of the Jerusalem Light Rail.<sup>179</sup> A month later Systra, a French state-owned company, withdrew its involvement in the construction of the "Red" and "Purple" light-rail lines after it faced questions from several trade unions, which denounced its involvement in the project.<sup>180</sup>

#### **Internships and Academic Visits**

Al-Haq maintains a robust database of reports, articles and documents describing supposed violations of international humanitarian law,<sup>181</sup> as part of its ongoing lawfare against Israel. As mentioned earlier, Al-Haq founded the Center for Applied International Law to train activists and students who will eventually influence local and national decision makers.<sup>182</sup> Al-Haq does so by "enriching" the academic and legal field regarding the Israeli-Palestinian conflict, assisted by interns from across

the world,<sup>183</sup> and by cooperating with well-known academic and research institutes.<sup>184</sup> Its "Rachel Corrie International Internship Program"<sup>185</sup> is named after the anti-Israel activist Rachel Corrie, a member of the BDS-supporting organization the International Solidarity Movement (ISM).<sup>186</sup>



York New University's International Law and Human Rights Fellowship Program, coordinated by three NYUaffiliated law centers, the Center for Human Rights and Global Justice (CHRGJ),<sup>187</sup> the Institute for International Law and Justice (IILJ)<sup>188</sup> and the Public Interest Law Center (PILC),<sup>189</sup> offered its students an option to intern at Al-Hag in 2018.190

Also, students from the Pozen Family Center for Human Rights at the University of Chicago can choose to intern with Al-Haq.<sup>191</sup>

Furthermore, Al-Haq is in Georgetown University's list of NGOs in which law students can choose to intern during the summer, or for post-graduate employment.<sup>192</sup>

Al-Haq's Rachel Corrie internship is also listed on the Lewis and Clark Law School website,<sup>193</sup> and on that of Central European University.<sup>194</sup>

In 2017, Prof. Ni Aolain from the University of Minnesota Human Rights Center visited Al-Haq's offices in Ramallah.<sup>195</sup> Following the visit, the university center hosted a discussion in which representatives from Al-Haq and other organizations from the BDS Movement were present.<sup>196</sup>



#### Delegations

Al-Haq "advocates for Palestinian rights" by hosting diplomatic delegations, and meeting with government officials. For example, in 2019 a delegation of Chilean officials met with Al-Haq staff in Ramallah.<sup>197</sup> For several years Al-Haq has been calling for the UN database of companies involved in Israeli settlements to be published,<sup>198</sup> and even launched a social campaign to that effect that was endorsed by the BDS Movement.<sup>199</sup> Two weeks after the visit, 62 members of Chile's parliament asked UN Human Rights Commissioner Michelle Bachelet, Chile's ex-president, to publish a UN-mandated database of companies that have business dealings with Israel's settlements.<sup>200</sup>

Additionally, on July 11, 2018, the Irish upper house, Seanad Éireann, passed the Control of Economic Activity Bill 2018, which bans the importation or sale of goods or services from settlements condemned by the United Nations and European Union as "illegal." The bill was proposed by Independent Senator Frances Black.<sup>201</sup> Members of the Fianna Fáil Party, the Irish Republican Party that voted in favor of the bill, had met with Al-Haq officials during their visit to the Palestinian Authority.<sup>202</sup> Moreover, Deputy Niall Collins, a member of the Fianna Fáil Party, specifically

thanked Dr. Susan Power, an Irish citizen and head of legal research and advocacy at Al-Haq,<sup>203</sup> for helping to promote this legislation.<sup>204</sup> Al-Haq congratulated the Irish senators for supporting this bill.<sup>205</sup>

#### Offices

Al-Haq's is based in Ramallah<sup>206</sup> but the organization has maintained offices around the world. In 2012, Al-Haq opened its European offices in The Hague and in Brussels, which were directed by Nada Kiswanson.<sup>207</sup> The offices were strategically located next to the European Parliament headquarters<sup>208</sup> and the International Criminal Court,<sup>209</sup> enabling Al-Haq to speedily submit reports and conduct lawfare with unfettered access to the highest international legal bodies.

In 2016, the Dutch authorities began investigating death threats made to Al-Haq's then-Europe office director Kiswanson.<sup>210</sup> She no longer works for Al-Haq,<sup>211</sup> and it is not certain whether the office still operates.

Furthermore, in 1990 two employees of Al-Haq, Charles Shamas<sup>212</sup> and Jim Fine,<sup>213</sup> opened the "Al-Haq Foundation for Human Rights" in Bristol, Pennsylvania.<sup>214</sup> Shamas, cofounder of Al-Haq Ramallah, is listed as the foundation's treasurer<sup>215</sup> and Fine, a former Al-Haq employee,<sup>216</sup> is listed as the director. The Al-Haq Foundation in Pennsylvania is registered under Fine's home address.<sup>217</sup>

Both Shamas and Fine are also leading figures in other BDS-supporting organizations; Shamas is a member of Human Rights Watch,<sup>218</sup> and Fine holds several positions in the Quaker organization American Friends Service Committee (AFSC).<sup>219</sup>

Although the foundation is still registered as active in Pennsylvania,<sup>220</sup> it has not published any official documents and no activity has been detected. Further, it is unclear whether it operates as Al-Haq's office in the United States, since there is no evidence of the connection between the two entities.

### Al-Haq's Involvement with other BDS Organizations

Al-Haq is one of the first "human rights" organizations established in the Arab world,<sup>221</sup> which made it a significant member of the Boycott, Divestment and Sanctions (BDS) Movement. Two of Al-Haq's co-founders, Jonathan Kuttab<sup>222</sup> and Charles Shamas,<sup>223</sup> are both leading members of other BDS organizations such as Nonviolence International<sup>224</sup> and Human Rights Watch.<sup>225</sup> Al-Haq also attended the Durban Conference in 2001,<sup>226</sup> where the BDS Movement was formed.<sup>227</sup>

Moreover, Al-Haq's director, Shawan Jabarin, attended a global BDS conference in Bethlehem in October 2009 along with other key figures from the BDS Movement such as Omar Barghouti (BDS National Committee),<sup>228</sup> Ameer Makhoul (Al-Quda Association),<sup>229</sup> Jamal Juma' (BDS National Committee,<sup>230</sup> Stop the Wall<sup>231</sup>), Dalit

Baum (Who Profits, AFSC),<sup>232</sup> Ingrid Jaradat Gassner (BDS National Committee<sup>233</sup> Badil<sup>234</sup>) and many more.<sup>235</sup>

Shawan Jabarin also attended a public meeting at the Al Bireh Municipality Hall along with Dr. Mustafa Barghouti (BDS National Committee and representative of Palestinian National and Islamic Forces)<sup>236</sup> and Nasser al-Khudwa (head of the Arafat Institution and former Palestinian minister of foreign affairs).<sup>237</sup>

Over the years Al-Haq has collaborated with numerous organizations in the BDS network. For instance, on May 8, 2019, Al-Haq, along with the US Campaign for Palestinian Rights (USCPR), International Federation for Human Rights (FIDH) and the American Friends Service Committee (AFSC), carried out a series of meetings with the officies of 15 members of the US Congress, along with EU and UN officials regarding what they view as "the pro-annexation policy" of the United States and its support in Israel.<sup>238</sup>

In 2016, Marya Farah and Aseil Abut-Baker, both legal researchers at Al-Haq, documented and presented Israel's "theft of natural resources" at an event in Washington, DC, organized by Jewish Voice for Peace (JVP),<sup>239</sup> another leading organization in the BDS Movement.<sup>240</sup>

In 2018, Al-Haq together with hundreds of international NGOs, most of which support the BDS Movement, signed a joint letter to the UN high commissioner for human rights asking her to publish an online database of businesses active in Israeli settlements.<sup>241</sup> Moreover, members of the US Palestinian Community Network (USPCN) delegation to the Palestinian Authority in 2018 met with Al-Haq to discuss their work on the local and international levels. USPCN emphasized Al-Haq's impactful work, calling it "the most prominent human rights organization in Palestine," despite its public support for terror and its ties to the PFLP. It is also worth noting that it has been labeled by the Israeli government as a supporter of terror and as a semi-terrorist organization.<sup>242</sup>

### **Al-Haq's Financials**

In the past few years Al-Haq has not been financially transparent, since the only information available on its website relates to the years 2004-2009.<sup>243</sup> Although Al-Haq began listing its partners in later years, it does not make any of its financial dealings or records available to the public. According to Al-Haq's financial statements for the aforementioned years, the organization received donations from numerous governments and governments agencies such as Belgium,<sup>244</sup> the Netherlands,<sup>245</sup> Spain,<sup>246</sup> Norway,<sup>247</sup> Ireland (through Irish Aid),<sup>248</sup> the Canadian International Development Agency,<sup>249</sup> the European Union,<sup>250</sup> the Spanish Agency for International Development Cooperation,<sup>251</sup> the Swedish International Development Agency (SIDA),<sup>252</sup> the United Nations Development Program and the European Commission.<sup>253</sup>

Furthermore, in 2004-2009 Al-Haq received financial support from American foundations such as the Ford Foundation,<sup>254</sup> Open Society Foundations<sup>255</sup> and Rights & Democracy.<sup>256</sup>

European Christian organizations, among them Global Ministries of the Uniting Protestant Churches in the Netherlands,<sup>257</sup> Christian Aid<sup>258</sup> and EED,<sup>259</sup> also donated to Al-Haq in the years mentioned.

Moreover, Al-Haq has received financial support from several international NGOs such as Diakonia,<sup>260</sup> Bread for the World (Brot für die Welt),<sup>261</sup> ICCO,<sup>262</sup> the Welfare Association,<sup>263</sup> Weltfriedensdienst e.v,<sup>264</sup> the Heinrich Boll Stiftung,<sup>265</sup> the Arab Human Rights Fund,<sup>266</sup> the Rosa Luxemburg Foundation<sup>267</sup> and the NGO Development Center.<sup>268</sup>

### Conclusion

Al-Haq, founded in the 1970s, has maintained strong affiliation to designated terror organizations Hamas and the Popular Front for the Liberation of Palestine, US-designated terror organizations whose violent agendas are diametrically opposed to the values that Al-Haq claims to champion. It has also has managed to establish, consolidate and strengthen its position as a prominent leader in Palestinian civil society and in the ongoing lawfare campaigns targeting the State of Israel. It has used its respected status as a senior so-called human rights organization to lend legitimacy and justification to the BDS Movement and its delegitimization campaigns against Israel. Similarly, Al-Haq's human rights advocacy did little to dissuade it from supporting in 2001 the release of its former staff member, attorney Daoud Darawi, after he was arrested for his connections to Palestinian Islamic Jihad and the PFLP.

## Palestinian Center for Human Rights (PCHR)



Main Findings

PCHR board members, including its director Raji Sourani, hold strong ties to the designated terror organizations Hamas and the Popular Front for the Liberation of Palestine (PFLP), with some board members even being former members of terror groups' "military" wings.

The organization functions as a documentation, research and information hub regarding human rights and international law in the Gaza Strip.

PCHR has hosted conferences, supposedly on human rights, but which have been attended by individuals such as Hamas political leader Ismail Haniyeh and Hamas international relations officer Basem Naim.

One PCHR member was imprisoned in Israel for collaborating with a Hezbollah commander who brutally killed four Israelis, including children.

Despite its strong terror connections, PCHR receives donations from governmental entities in various European countries. It also receives donations from international organizations considered to be reputable such as Oxfam Novib and Grassroots International.

### Background

The Palestinian Centre for Human Rights (PCHR) is a non-governmental organization (NGO) based in the Gaza Strip.<sup>269</sup> Established in 1995 by a group of Palestinian lawyers and human rights activists, the organization claims to be dedicated to "protecting human rights, promoting the rule of law and upholding democratic principles" in

the West Bank and the Gaza Strip.<sup>270</sup> The organization functions as a documentation, research and information hub regarding human rights and international law in the Gaza Strip. PCHR holds special consultative status with the Economic and Social Council (ECOSOC) of the United Nations<sup>271</sup> and is an affiliate of the International Commission of Jurists (Geneva).<sup>272</sup> PCHR has offices in Gaza City, Jabalya, Khan Yunis, all in the Gaza Strip, and in the West Bank.<sup>273</sup> It does not officially support the Boycott, Divestment and Sanctions (BDS) Movement. However, it is a member of several coalitions that do.<sup>274</sup>

#### Partners

PCHR is a member of several international and regional coalitions, most of which endorse the BDS Movement.<sup>275</sup> Partnering with other coalitions in the BDS network enables PCHR to extend its influence within the field.<sup>276</sup>

Along with other Palestinian NGOs, PCHR is a member of the International Federation for Human Rights (FIDH),<sup>277</sup> a coalition fully supportive of the BDS Movement.<sup>278</sup> It is also a member of the Euro-Mediterranean Human Rights Network,<sup>279</sup> a network of more than 80 human rights organizations,<sup>280</sup> many of which support the BDS Movement such as Human Rights Watch,<sup>281</sup> Amnesty International,<sup>282</sup> the Cairo Institute for Human Rights Studies (CIHRS),<sup>283</sup> etc.<sup>284</sup>

Furthermore, PCHR is a member of the Palestinian Human Rights Organizations Council (PHROC),<sup>285</sup> a coalition comprised of several Palestinian NGOs<sup>286</sup> supporting the BDS Movement.<sup>287</sup>

PCHR is also a member of the Kumi Now (Rise Up) project, together with other Israeli and Palestinian NGOs<sup>288</sup> aiming to change the status quo in the Palestinian Authority and Gaza by promoting non-violent resistance, advocacy and legal action.<sup>289</sup> Finally, PCHR is affiliated with the International Legal Assistance Consortium (ILAC), the World Coalition against the Death Penalty, and the Arab Organization for Human Rights (AOHR).<sup>290</sup>

### Collaboration

PCHR collaborates with numerous local and international organizations in the BDS Movement.

#### Stop the Wall (STW)

In 2006 PCHR collaborated with Stop the Wall, a member of the BDS National Committee (BNC),<sup>291</sup> in the campaign "Stop support for Israel's war crimes."<sup>292</sup> The campaign was launched after a New Zealand judge issued an arrest warrant for Moshe Ya'alon, former Israeli Chief of Staff, who eventually managed to leave the country without being arrested.<sup>293</sup>

The BNC was created in 2008 and is the coordinating body for the BDS Movement worldwide.<sup>294</sup> The first and primary member of the BNC is the Council of National and Islamic Forces in Palestine,<sup>295</sup> known outside the Palestinian territories as the "Palestinian National and Islamic Forces" (PNIF). PNIF is composed of five US-designated terrorist organizations:<sup>296</sup> Hamas, the Popular Front for the Liberation of Palestine (PFLP), the Popular Front for the Liberation of Palestine (PFLP), the Palestine Liberation Front (PLF) and Palestinian Islamic Jihad (PIJ).<sup>297</sup>

#### Al Mezan

PCHR collaborated with Al Mezan, another Palestinian NGO operating in Gaza,<sup>298</sup> and the International Solidarity Movement (ISM), in the "Free the Holy Land Sea" campaign, calling for an end to Israel's blockade of the Gaza Strip.<sup>299</sup> Al Mezan holds strong ties to the designated terror organization Hamas,<sup>300</sup> and its general director, Issam Younis, has shown support for Hamas as a movement and as a government.<sup>301</sup>

#### Unadikum

PCHR, together with AI Mezan and Unadikum – a Spanish BDS-supporting organization<sup>302</sup> – launched a campaign for Palestinian security prisoners in 2014.<sup>303</sup> Unadikum and its members openly support organizations that have been designated as terror outfits by the US<sup>304</sup> and the EU,<sup>305</sup> such as the PFLP,<sup>306</sup> Hezbollah<sup>307</sup> and the Izz ad-Din al-Qassam Brigades.<sup>308</sup>

#### USCPR

PCHR and other leading organizations in the BDS Movement such as the BNC<sup>309</sup> and the US Campaign for Academic and Cultural Boycott of Israel (USACBI)<sup>310</sup> were mentioned in the "Student divestment campaigns" handbook<sup>311</sup> issued by the US Campaign to End the Israeli Occupation, known today as the US Campaign for Palestinian Rights (USCPR). This handbook provided an overview of campus divestment strategies for student BDS activists, which it said could be assisted by PCHR and other BDS organizations' divestment campaigns.<sup>312</sup>

PCHR also collaborates with other Palestinian NGOs engaging in continuous lawfare campaigns against the State of Israel such as organizing diplomatic briefing with Al-Haq,<sup>313</sup> publishing joint press releases with Al-Dameer<sup>314</sup> and organizing workshops with Al Mezan.<sup>315</sup>

#### **Significant Interactions**

In 2016, the Institute for Policy Studies (IPS) in Washington hosted the "Palestine: human rights and humans wronged" event, featuring Raji Sourani of PCHR and Shawan Jabarin of Al-Haq.<sup>316</sup> The conversation was moderated by Phyllis Bennis, an important figure in the BDS field. Bennis is the director of the New Internationalism Project at IPS,<sup>317</sup> a board member of Jewish Voice for Peace (JVP)<sup>318</sup> and co-founder of the US Campaign for Palestinian Rights (USCPR).<sup>319</sup> The event was co-sponsored by leading organizations from the BDS Movement such as Code Pink,<sup>320</sup> the American Friends Service Committee (AFSC),<sup>321</sup> US Palestinian Community Network (USPCN),<sup>322</sup> Jewish Voice for Peace – DC Metro,<sup>323</sup> and others.<sup>324</sup>

### Scope of Work

PCHR mainly engages in activities that entail legal action against the State of Israel. To this end, its work mainly consists of publishing pro-Palestinian posters,<sup>325</sup> producing weekly reports on the situation in Gaza,<sup>326</sup> advocating for Palestinian rights,<sup>327</sup> providing legal aid and counsel to individuals and groups,<sup>328</sup> hosting international

delegations,<sup>329</sup> obtaining arrest warrants against Israeli officials,<sup>330</sup> conducting research,<sup>331</sup> gathering supposedly incriminating evidence against Israeli policies in the Gaza Strip,<sup>332</sup> submitting reports to the International Criminal Court<sup>333</sup> and the United Nations,<sup>334</sup> hosting fellowships and training sessions for law students<sup>335</sup> and organizing workshops and seminars related to human rights.<sup>336</sup>

In addition, as part of its lawfare campaign against Israel,<sup>337</sup> PCHR frequently describes Israel as an "apartheid state"<sup>338</sup> and accuses it of carrying out "ethnic cleansing"<sup>339</sup> and "war crimes"<sup>340</sup> against the Palestinians. Also, during operation "Protective Edge" in 2014, PCHR's director Raji Sourani<sup>341</sup> compared Israel's Prime Minister Benjamin Netanyahu to the world's formerly most wanted terrorist<sup>342</sup> Osama bin Laden.<sup>343</sup>

PCHR has a bigger impact on the international community than other Gaza-based NGOs engaging in lawfare against Israel due to its presence in global conferences,<sup>344</sup> delegations<sup>345</sup> and campaigns.<sup>346</sup> PCHR also cooperates with leading organizations in the BDS Movement,<sup>347</sup> which has enabled it to build a reputation as a leading figure in ongoing anti-Israel lawfare projects.<sup>348</sup>

In addition, PCHR is very active on social media platforms such as Facebook (with more than 40,150 likes)<sup>349</sup> and Twitter (with almost 13,000 followers).<sup>350</sup> In 2016, during World Press Freedom Day, PCHR launched a social media campaign titled "No to Silencing the Press," aimed at "unveiling the Israeli crimes committed against journalists" as well as the "Palestinian Authority violations against journalists, opinion makers and bloggers in West Bank and Gaza Strip."<sup>351</sup> In the same year, PCHR launched the "lighting Gaza" advocacy campaign on Facebook and Twitter,<sup>352</sup> aimed at raising awareness of the electric power crisis in Gaza.<sup>353</sup>



#### Raji Sourani's Personal Terror Record

PCHR director Raji Sourani was convicted and sentenced to three years in prison by Israeli authorities in the late 1970s for his membership in the Popular Front for the Liberation of Palestine (PFLP).<sup>354</sup> The PFLP is a designated terror organization in the United States,<sup>355</sup> EU,<sup>356</sup> Israel<sup>357</sup> and Canada.<sup>358</sup>

Following his release, he renounced his PFLP affiliation,<sup>359</sup> but he has continued to hold regular meetings with its leaders.<sup>360</sup> His serving in 2002 as the lawyer for Ahmed Sa'adat,<sup>361</sup> the secretary general of the PFLP, is further testament to his affiliation or support for the terror group.<sup>362</sup>

Sa'adat was sentenced to 30 years in Israeli jail for planning the 2001 murder of Israeli minister Rehavam Ze'evi and for his leadership position in the PFLP.<sup>363</sup> This apparent support continued all the way into 2017 when Sourani attended and spoke at Ahmed Sa'adat's book launch, organized by the PFLP in Gaza.<sup>364</sup>



Sourani also has clear ties to members of the Hamas terror organization. In 2011, for example, he met in Cairo with Musa Abu Marzouk, a member of Hamas' Political Bureau.<sup>365</sup> The same year, Sourani met with Khaled Mashal, chairman of the Hamas Political Bureau.<sup>366</sup> The US Department of State has designated both Marzouk and Mashal as Global Terrorists.<sup>367</sup>

Moreover, in 2012 Ismail Haniyeh welcomed a delegation of the International Association of Democratic Lawyers (IADL) to the Gaza Strip.<sup>368</sup> Sourani is a member of the IADL executive committee.<sup>369</sup> Years later in 2017, Haniyeh met with a delegation of human rights and civil society institutions headed by Sourani.<sup>370</sup> During operation "Protective Edge" in 2014, Sourani described Hamas as a "resistance group," saying "they are a part of us, part of our chemistry."<sup>371</sup>

In 2013, a delegation of PFLP leaders visited the PCHR office in the Gaza City to congratulate Sourani for winning the "alternative Nobel Prize."<sup>372</sup> Later in 2014, the PFLP in Gaza again organized a ceremony to honor Sourani for winning the prize.<sup>373</sup>

In 2017, PCHR hosted a delegation of the Hamas Information Office headed by Mushir al-Masri, a Hamas member of the Palestinian Legislative Council (PLC), along with Fawzi Barhoum, Hamas' spokesperson, Taher al-Nunu, media advisor to the head of the Hamas Political Bureau, and Salamah Ma'rouf, head of the Government Information Office in Gaza.<sup>383</sup>

Moreover, several board members of PCHR have strong ties to the PFLP and Hamas. As a consequence, over the years Israeli authorities have refused to grant exit permits from Gaza to multiple staff members of the PCHR.<sup>384</sup>

For instance, PCHR board member Jaber Wishah<sup>385</sup> is a former commander of the "military" wing of the PFLP.<sup>386</sup> He was imprisoned by Israel for his collaboration with terrorist Samir Kuntar,<sup>387</sup> a Hezbollah commander who committed a deadly terror attack in 1979, killing four Israeli civilians.<sup>388</sup> One of Kuntar's victims was a four-year-old girl whom he killed by beating her head repeatedly with a rifle butt.<sup>389</sup> Wishah's mother, Um Jaber Wishah, acted as a foster mother, according to Arabic media, to Kuntar and supported him until his release from Israeli prison in 2008.<sup>390</sup>

PCHR board member Nadia Abu Nahla<sup>391</sup> is the executive director of the Women's Affairs Technical Committee (WATC).<sup>392</sup> In 2018, online credit card donations facilities were withdrawn from WATC due to its ties to terror groups.<sup>393</sup>

Iyad Alami, a lawyer and the head of Legal Aid Program and Legal Unit at PCHR,<sup>394</sup> has in the past represented and defended several Hamas leaders, among them Hamas' spokesperson and co-founder,<sup>395</sup> Abdel Aziz Rantisi.<sup>396</sup>

Reyad Al-Zanoun, another board member of PCHR,<sup>397</sup> is also a member of the Muslim Brotherhood,<sup>398</sup> which has been designated as terrorist by the State of Israel,<sup>399</sup> Russia,<sup>400</sup> Egypt,<sup>401</sup> Saudi Arabia<sup>402</sup> and the United Arab Emirates.<sup>403</sup>

Additionally, PCHR collaborates with terror-affiliated NGOs such as Al-Haq,<sup>404</sup> Al Mezan<sup>405</sup> and Addameer,<sup>406</sup> which have staff members<sup>407</sup> with strong ties<sup>408</sup> to the PFLP and Hamas.<sup>409</sup>

Moreover, PCHR has supported Hamas and PIJ engineered and controlled Great March of Return (GRM),<sup>410</sup> which was described as a civilian, non-violent protest of Palestinians in Gaza, aiming to highlight their so-called right of return.<sup>411</sup> However,

these marches were frequently accompanied by terror acts against the State of Israel, such as the launching of incendiary kites,<sup>412</sup> Molotov cocktails and burning tires.<sup>413</sup> The GRM is controlled by a "high committee"<sup>414</sup> composed of representatives from designated<sup>415</sup> terror organizations such as Hamas,<sup>416</sup> the PFLP<sup>417</sup> and Palestinian Islamic Jihad (PIJ).<sup>418</sup> Furthermore, Ismail Haniyeh has publicly supported the GRM events and has participated in some of them.<sup>419</sup> In its publications, PCHR ignores the fact that the GRM is controlled by terror organizations and is accompanied by violent acts. Rather, it accuses Israel of "targeting peaceful protesters."<sup>420</sup>

#### **Financials & Registration**

PCHR is registered as a non-profit private shareholder company located in Gaza.<sup>421</sup>

It has not published its audit reports since 2008, during which its revenue totaled \$1,642,525.<sup>422</sup> This marked an increase of 93.5% since 1997.<sup>423</sup> While the organization does provide information on its key donors, it does not specify the value of the grants received from each donor.<sup>424</sup>

In the past years, PCHR has received financial support from Christian organizations such as Dan Church Aid and Christian Aid.<sup>425</sup>

Moreover, PCHR had received donations from government entities such as the Representative Office of Finland, Representative Office of Norway, Norwegian Refugee Council (NRC), Irish Aid, San Sebastian Municipal Council, Human Rights and International Humanitarian Law Secretariat, Spanish Agency for International Development Cooperation (AECID), European Commission (through Oxfam), United Nations Development Program (UNDP) and the United Nations Voluntary Fund for

#### Victims of Torture (UNVFVT).426

Donations to PCHR have also come from international organizations and foundations such as the NGO Development Center (NDC), Bertha Foundation, Arab Human Rights Fund (AHRF), Open Society foundation, Al-Maqdese for Society Development (MSD), Iris O'Brien Foundation, Trocaire, Terre des hommes foundation (TDH), Kvinna Till Kvinna Foundation (KTK) and Oxfam Novib. The BDS- supporting organizations Al-Quds Association and US-based Grassroots International<sup>427</sup> have also donated to PCHR in recent years,<sup>428</sup> and in 2014 the Samuel Rubin Foundation gave a grant to PCHR through Grassroots International.<sup>429</sup>

In 2018, PCHR along with three other Palestinian NGOs that had a donations page operated by Grassroots International had their credit card facilities withdrawn due to their connections to designated terror organizations and the BDS Movement.<sup>430</sup>

According to its website, PCHR only receives donations through wire transfer to the following bank accounts: Al Quds Bank in Gaza (455513), UPI Banca in Italy (10268) and Bank of New York in the United States (8901122769).<sup>431</sup>

In addition, PCHR only accept donations from organizations and individuals that "support universal values of human rights and the use of international humanitarian law to end the occupation of Palestine," and does not accept anonymous donations.<sup>432</sup> Conclusions

PCHR, founded in the 1990s, has established itself as one of the leading organizations in the ongoing anti-Israel lawfare campaigns. It partners and collaborates with other Palestinian organizations and coalitions engaging in the same field of work, which allows it to gain local and global recognition and prominence. Although it claims to be dedicated to protecting human rights and promoting the rule of law, many of its board members and staff, including its founder and director, have longstanding and alarming ties to designated terror organizations such as the PFLP and Hamas. One of its board members was even imprisoned for collaborating with a Hezbollah terrorist who killed four Israelis, brutally beating one of them, aged four, to death with his rifle butt.

Despite its many encounters with PFLP officials, its frequent meetings with the highest echelons of the Hamas terror movement and open praise for the Gazaruling organization, PCHR continues to receive funding from organizations that claim to champion human rights such as Grassroots International. In addition, funding has flowed into PCHR's coffers from international governmental organizations in Norway, Spain, Ireland and Finland and from the UN.

## Al Mezan Center for Human Rights



### Main Findings

Al Mezan engages in lawfare against the State of Israel on a regional and international level.

The organization does not operate on its own, but rather partners with other organizations, networks and coalitions from the BDS Movement.

The organization maintains strong connections to the US-designated terror organization Hamas.

Al Mezan functions as a documentation, research and information hub regarding human rights and international law in the Gaza Strip.

### Background

Al Mezan Center for Human Rights is a Palestinian non-governmental organization based in the Gaza Strip. The organization's main office is located in the upscale A-Rimal neighborhood of Gaza City, while another two offices are located in Jabaliya and Rafah.<sup>433</sup> Established in 1999, Al Mezan "aims to promote, advocate and protect human rights, especially economic, social and cultural rights, in the Gaza Strip."<sup>434</sup> Al Mezan endorses and supports the Boycott, Divestment and Sanctions (BDS) Movement,<sup>435</sup> engages in lawfare and takes legal measures against the State of Israel on the regional and international levels.<sup>436</sup>

### Members & Staff

#### Issam Younis

Younis is the director general of Al Mezan Center for Human Rights<sup>439</sup> and a member of Gaza's Al-Azhar University's board of trustees. He also serves as vice chairman of the board of the Gaza Community Mental Health Program.<sup>440</sup> Younis holds senior positions in other BDS-affiliated organizations including as the commissioner general of the Independent Commission for Human Rights (ICHR).<sup>441</sup> He is also a policy advisor at Al-Shabaka Palestinian Policy Network<sup>442</sup> along with other BDS key figures such as Omar Barghouti, co-founder of the BDS Movement.<sup>443</sup>

#### Dr. Azmi Shuaibi

Shuaibi is a board member of Al Mezan<sup>444</sup> and of MIFTAH, a Palestinian NGO advocating for Palestinian rights on both the local and international levels.<sup>445</sup> He is also a consultant for the Coalition for Integrity and Accountability's (AMAN) Board of Directors.<sup>446</sup>

#### **Partners**

Al Mezan is a member of several international and regional coalitions, most of which endorse the BDS Movement. Partnering with other coalitions in the BDS network allows Al Mezan to expand its field of work and impact.

For example, it is a member of the Economic, Social and Cultural Rights Network (ESCR Network),<sup>447</sup> composed of over 280 social movements, NGOs and advocates across the world.<sup>448</sup>

Appendix - Al Mezan Center for Human Rights

Along with other Palestinian NGOs, Al Mezan is a member of the International Federation for Human Rights (FIDH),<sup>449</sup> whose membership is fully supportive of the BDS Movement<sup>450</sup> and of the Coalition for Accountability and Integrity (AMAN).<sup>451</sup>

Al Mezan is also a member of the Euro-Mediterranean Human Rights Network (EMHRN),<sup>452</sup> a network of more than 80 human rights organizations,<sup>453</sup> many of which support BDS groups, for example Human Rights Watch,<sup>454</sup> Amnesty International,<sup>455</sup>the Cairo Institute for Human rights Studies (CIHRS),<sup>456</sup> etc.<sup>457</sup>

Furthermore, Al Mezan is a member of the Palestinian Human Rights Organizations Council (PHROC), a coalition of several Palestinian NGOs<sup>458</sup> supporting the BDS Movement,<sup>459</sup> and of the Kumi Now (Rise Up) project, together with other Israeli and Palestinian NGOs<sup>460</sup> aiming to change the reality in the Palestinian Authority and Gaza by promoting non-violent resistance, advocacy and legal action.<sup>461</sup>

Finally, Al Mezan is a member of the Habitat International Coalition – Housing and Land Rights Network. However, no evidence was found during this research that the coalition supports BDS.<sup>462</sup>

### Collaboration

Al Mezan collaborates with numerous local and international organizations from the BDS Movement.

In 2012, it participated in the World Social Forum – Free Palestine in Brazil as part of its membership in the Palestinian Human Rights Organizations Council (PHROC).<sup>463</sup> This event gathered international pro-Palestinians activists and NGOs to discuss

the position of the BDS Movement in the Palestinian "resistance." 464

In 2014, Al Mezan joined the call "against the Apartheid wall" endorsed by the BDS National Committee (BNC) and other organizations from the BDS network.<sup>465</sup>

Al Mezan participated in the "Obliterated Families" project, a multimedia documentary that recorded the lives of families in the Gaza Strip during the 2014 Israel-Hamas conflict.<sup>466</sup> Later, in 2015 Al Mezan collaborated with Visualizing Palestine in a joint campaign initiative documenting "Israel's attacks against the Gaza Strip during 2014."<sup>467</sup> Moreover, Al Mezan along with the Palestinian Centre for Human Rights (PCHR), an NGO operating in Gaza,<sup>468</sup> and the International Solidarity Movement (ISM), took part in "Free the Holy Land Sea" campaign, calling to end the blockade on the Gaza Strip.<sup>469</sup> In 2019, Al-Haq, PCHR and Al Mezan attended the UN Human Rights Council meeting in Geneva to debate issues relating to human rights violations in the Palestinian Authority and the Gaza Strip.<sup>470</sup>

### Scope of Work

The bulk of Al Mezan's efforts are dedicated to delegitimizing the State of Israel. This entails advocating for Palestinian human rights before international judicial bodies,<sup>471</sup> obtaining arrest warrants against Israeli officials,<sup>472</sup> conducting research and gathering supposedly incriminating evidence against Israeli policies in the Gaza Strip,<sup>473</sup> publishing brochures containing visuals of alleged human rights violations,<sup>474</sup> and submitting reports to the International Criminal Court.<sup>475</sup>

Al Mezan also monitors and documents human rights violations in the Gaza Strip and compiles statistics on casualties.<sup>476</sup> Using its media center, Al Mezan publishes press releases, briefs, statements and position papers.<sup>477</sup>

In addition, AI Mezan hosts workshops on international humanitarian law<sup>478</sup> and holds legal training for lawyers<sup>479</sup> and students<sup>480</sup> in Gaza.

As part of its lawfare campaign against Israel, Al Mezan employs rhetoric and narratives intended to portray Israel as an apartheid state<sup>481</sup> that commits "ethnic cleansing" against the Palestinians.<sup>482</sup> In 2019, Al Mezan published a report on the attack on "unarmed protesters" at the Great March of Return riots in the Gaza Strip,<sup>483</sup> which Hamas leaders have attended and publicly supported.<sup>484</sup>

Another function carried out by Al Mezan is to operate as an information hub in the field of human rights in the Gaza Strip.<sup>485</sup>

Al Mezan does not operate independently within the BDS Movement, but rather through partnerships with coalitions that use its information,<sup>486</sup> enabling it to expand its field of work and impact.<sup>487</sup>

### **Red Flags**

#### **Terror Connections**

In 2012, Al Mezan's general director, Issam Younis, met with Hamas official<sup>488</sup> Khaled Mashal in Cairo.<sup>489</sup> Following the visit, Younis published an open letter in support of Hamas as a movement and as a government, declaring: "I remain an advocate of the right of Hamas to govern and I absolutely reject the double standards employed by the international community towards the movement."

In 2018, Younis also met with Ismail Haniyeh,<sup>491</sup> head of Hamas' Political Bureau,<sup>492</sup> as the commissioner general at the Independent Commission for Human Rights (ICHR).<sup>493</sup>

Hamas is a designated terror organization in the US,<sup>494</sup> EU,<sup>495</sup> Canada<sup>496</sup> and Israel.<sup>497</sup> The US Department of State has classified both Ismail Haniyeh<sup>498</sup> and Khaled Mashal<sup>499</sup> as Designated Global Terrorists.

In addition, Al Mezan collaborates with terror-affiliated NGOs such as Al-Haq<sup>500</sup> and Addameer,<sup>501</sup> both of which have staff members<sup>502</sup> with strong ties<sup>503</sup> to the designated terror organization the Popular Front for the Liberation of Palestine (PFLP).<sup>504</sup> In 2017, Al-Haq and Al Mezan were invited to speak at a UN forum in New York. In response, Israeli officials accused the UN of "colluding with supporters of terrorism seeking to harm Israel."<sup>505</sup>

### **Financials & Registration**

Al Mezan is not financially transparent and only once publicized its list of donors in 2016. Beyond this, the organization does not provide any financial statement or information about its annual income, except for its account details at Quds Bank.<sup>506</sup> According to its website,<sup>507</sup> in 2016 the organization received donations from government entities such as the Representative Office of Norway to the Palestinian Authority, the UN Program of Assistance to the Palestinian People (UNDP/PAPP), the Human Rights and International Humanitarian Law Secretariat,<sup>508</sup> the European Commission, the Palestinian Central Election Commission and the state-supported<sup>509</sup> organization Medico International (Germany).<sup>510</sup>

Al Mezan also received financial support from international NGOs and foundations such as Diakonia, the Sigrid Rausing Trust, Open Society Foundations (OSF), ICCO and Kerk in Actie, the Norwegian Refugee Council and the BDS-supporting organization known as American Friends Service Committee (AFSC).<sup>511</sup>

Code Pink, a leading organization in the BDS Movement,<sup>512</sup> has served as Al Mezan's fiscal sponsor for grants from the Cultures of Resistance Network.<sup>513</sup>

### Main Findings

Al-Dameer engages in lawfare against the State of Israel on a regional and international level, partnering with other organizations and coalitions from Palestinian civil society.

It plays a significant role in lawfare campaigns against Israel, such as producing and submitting reports, together with other Palestinian legal NGOs, to the International Criminal Court (ICC).

Most of Al-Dameer's former and current board members have strong ties to the designated terror organization the Popular Front for the Liberation of Palestine (PFLP).

Al-Dameer has close ties with other terror-affiliated NGOs operating in Gaza and in the West Bank, and has shown public support for members of designated terror organizations.

Despite its strong ties to the PFLP, the organization continues to receive donations from governments and non-governmental entities such as the European Union and US charities.

### Background

Al-Dameer Association for Human Rights is a Palestinian non-governmental organization (NGO) based in Gaza City.<sup>514</sup> Established in 1993 by a group of Palestinian lawyers, human rights activists and the Ramallah-based NGO Addameer,<sup>515</sup> the organization claims to be dedicated to playing "a leading role in the development, respect, protection, dissemination and promotion of human rights in Palestinian

society."<sup>516</sup> In 1996, due to the difficulties of traveling between the Gaza Strip and the West Bank, Al-Dameer decided to become administratively and financially independent from the office in Ramallah, although it claims a "high-level of coordination and communication between both offices," with the two representing each other in their respective parts of the Palestinian territories as well as in international conferences and forums.<sup>517</sup>

Al-Dameer endorses and supports the Boycott, Divestment and Sanctions (BDS) Movement<sup>518</sup> and engages in legal actions against the State of Israel in both regional<sup>519</sup> and international arenas.<sup>520</sup>

#### **Partners**

Al-Dameer is a member of several international and regional coalitions, most of which endorse the BDS Movement.

The organization is a member of the Palestinian Human Rights Organizations Council (PHROC),<sup>521</sup> a coalition of several Palestinian NGOs supporting the BDS Movement.<sup>522</sup> The PHROC submits reports and letters to the International Criminal Court<sup>523</sup> and the United Nations, in which it condemns the State of Israel.<sup>524</sup>

Furthermore, Al-Dameer is a member of PNGO,<sup>525</sup> an umbrella organization of Palestinian NGOs that are based in the West Bank, Israel and Gaza.<sup>526</sup> PNGO is

a leading member in the Boycott, Divestment and Sanctions National Committee (BNC),<sup>527</sup> which operates as the coordinating body for the BDS Movement worldwide.<sup>528</sup> Al-Dameer is also a member of the Arab NGO Network for Development (ANND), the Child Rights International Network (CRIN), the Emergency Water, Sanitation and Hygiene group (EWASH), the Civil Network to Protect the Right to Freedom of Associations and the Palestinian Coalition Against Torture.<sup>529</sup>

#### Collaboration

Al-Dameer collaborates with numerous local and international organizations from the BDS Movement. As part of its membership in several Palestinian civil society coalitions,<sup>530</sup> Al-Dameer partners with the Gaza-based NGO Al Mezan<sup>531</sup> and the Ramallah-based NGO Al-Haq,<sup>532</sup> both leaders in the lawfare campaigns against Israel.<sup>533</sup> Additional significant partners of Al-Dameer include the Gaza-based NGO the Palestinian Centre for Human Rights (PCHR)<sup>534</sup> and Addameer,<sup>535</sup> a Ramallahbased NGO that promotes security prisoners' rights.<sup>536</sup> Together, they engage in legal actions targeting Israel,<sup>537</sup> for example calling for the UN database of companies involved in Israeli settlements to be published.<sup>538</sup>

Furthermore, in 2014, Al-Dameer collaborated with Visualizing Palestine in a campaign documenting "Israel's attacks during the 2014 offensive against the Gaza Strip."<sup>539</sup>

Also, in 2013 Al-Dameer's former executive director<sup>540</sup> Khalil Abu Shammala participated in the "Gaza conference" in London, hosted by the BDS-supporting organization<sup>541</sup> the Palestine Solidarity Campaign (PSC).<sup>542</sup> Other participants included Raji Sourani, director of the Palestinian Centre for Human Rights (PCHR),<sup>543</sup> and Mona El-Farra, a consultant for the Union of Health Work Committees.<sup>544</sup>

Moreover, in 2010, Al-Dameer joined the campaign to preserve Mamilla Jerusalem Cemetery, along with US legal consuls and Palestinian NGOs operating in Jerusalem such as Al-Haq, Jerusalem Legal Aid and Human Rights Center, Addameer, etc.<sup>545</sup> As part of this campaign, the organizations sent a petition to UN officials and the government of Switzerland asking them to take "urgent action on human rights violations by Israel."<sup>546</sup>

### Scope of Work

#### Lawfare against Israel

The bulk of Al-Dameer's efforts are dedicated to defaming and delegitimizing the existence of the State of Israel. This entails advocating against Israel before international judicial bodies,<sup>547</sup> submitting reports to the International Criminal Court,<sup>548</sup> meeting with European government officials,<sup>549</sup> publishing videos<sup>550</sup> and brochures containing visuals of alleged human rights violations,<sup>551</sup> conducting research<sup>552</sup> and issuing position papers on Israeli policies in the Gaza Strip.<sup>553</sup>

In addition, as part of its lawfare campaign against Israel,<sup>557</sup> Al-Dameer frequently accuses Israel of carrying out "war crimes"<sup>558</sup> and "collective punishment"<sup>559</sup> against Palestinians and of attempting to carry out a "racist plan" to "Judaize Jerusalem" in favor of the Jewish population over the Palestinians.<sup>560</sup>

In the past few years, Al-Dameer has collaborated with other Palestinian NGOs engaging in legal actions against the State of Israel, such as PCHR, Al-Haq and Al Mezan.<sup>561</sup> The four NGOs have submitted six reports to the ICC on the "violation of human rights" and "war crimes" allegedly committed by Israel in the Gaza Strip and the West Bank.<sup>562</sup>

#### Supporting the BDS Movement

Al-Dameer supports and endorses BDS campaigns worldwide. For example, in 2014 it supported the campaign run by the BDS organization Addameer against the G4S security company.<sup>563</sup> This campaign called on the Gates Foundation to stop funding G4S, a British firm that provides security services and equipment to Israel's Prison Service.

In 2016, AI-Dameer, together with other PHROC members, signed a pro-BDS statement, describing it as "an important nonviolent counter-narrative and alternative for achieving the enjoyment and exercise of freedom, dignity, and justice."<sup>564</sup>

In addition, Al-Dameer's former director Khalil Abu Shammala<sup>565</sup> signed a petition in 2011 calling on the Dutch government to divest from the Veolia transport company and to block it from being awarded tenders for public projects.<sup>566</sup> The call came as a result of Veolia's involvement in constructing the Jerusalem Light Rail, which the BDS Movement described as a "violation of human rights."<sup>567</sup> In 2013, a French court ruled that this construction was legal under international law.<sup>568</sup>

In 2019, AI-Dameer signed the PHROC statement, in which it condemns the US entry ban on Omar Barghouti,<sup>569</sup> co-founder of the BDS Movement and the representative of the Palestinian Campaign for Academic and Cultural Boycott of Israel (PACBI).<sup>570</sup> In this statement, PHROC described the BDS Movement as a "peaceful resistance and solidarity movement."<sup>571</sup>

### **Terror Connections**

#### Al-Dameer board's connection to terror

Most of Al-Dameer's board members have strong ties to the Popular Front for the Liberation of Palestine (PFLP), a designated terror organization in the United States,<sup>572</sup> EU,<sup>573</sup> Israel<sup>574</sup> and Canada.<sup>575</sup>

For example, Younes Al-Jero, chairman of Al-Dameer's board,<sup>576</sup> is a former senior member of the PFLP.<sup>577</sup> He worked for more than 35 years with Rabah Muhanna,<sup>578</sup> a member of the PFLP Political Bureau in the Gaza Strip.<sup>579</sup> In 2019, when Muhanna died, Jero eulogized him as "a brave man with a strong vision."<sup>580</sup>

Ahmed Huneideq and Yahyah Al-Ghalban, both Al-Dameer board members,<sup>581</sup> are also former members of the PFLP.<sup>582</sup> Al-Ghalban was a member of the PFLP's Central Committee<sup>583</sup> and was described as a "comrade" on the PFLP's website.<sup>584</sup> Also, Khalil Abu Shammala, Al-Dameer's former director,<sup>585</sup> is a member of the PFLP.<sup>586</sup>

Additionally, the secretary of Al-Dameer's board, Raafat Salha,<sup>587</sup> represented the PFLP at a joint conference of Fatah, Hamas and Palestinian Islamic Jihad (PIJ) on the Bar Association elections.<sup>588</sup> Both Hamas and PIJ are terror organizations, according to the US Department of State.<sup>589</sup>

Another leading member of Al-Dameer's board, Dr. Jalal Shabat,<sup>590</sup> spoke at the 49th anniversary of the opening of Al-Quds Open University in Gaza, before the university's staff and the PFLP leadership.<sup>591</sup> Shabat, a professor at Al-Quds Open University,<sup>592</sup> congratulated members of the PFLP and praised the "national efforts and the enormous sacrifices that the Popular Front has made to protect the Palestinian national project."<sup>593</sup>

In addition, Ilham Garghoun, a former Al-Dameer board member,<sup>594</sup> participated in a PFLP seminar on the electricity crisis in Khan Younis in 2015.<sup>595</sup> The conference was hosted by Jamil Mazher,<sup>596</sup> a member of the PFLP's Political Bureau and leader of its branch in Gaza.<sup>597</sup>

Furthermore, Al-Dameer's executive director, Hala Jaber,<sup>598</sup> and secretary of the board, Raafat Salha,<sup>599</sup> are also board members of the Union of Health Work Committees (UHWC),<sup>600</sup> a Gaza-based organization that is affiliated with the PFLP.<sup>601</sup> The organization was described by USAID as the "PFLP's health organization," alongside other institutes such as the Union of Agricultural Work Committees (UAWC) and the Union of Palestinian Women's Committees (UPWC)."<sup>602</sup> Moreover, UHWC has organized several events with the PFLP.<sup>603</sup>

Al-Dameer has been described as a PFLP affiliate.<sup>604</sup> Indeed, the PFLP has often defended Al-Dameer. For example, in 2009 the terror group condemned the raids on Al-Dameer's office in Gaza, insisting that the organization is merely "a national and professional institution, which plays an important and effective role in defending human rights in the Gaza Strip."<sup>605</sup>

As mentioned above, Al-Dameer was established in cooperation with Addameer Prisoner Support and Human Rights Association, a Ramallah-based NGO defending security prisoners' rights.<sup>606</sup> Most of Addameer's current and former board members (Abdul-Latif Ghaith,<sup>607</sup> Yaqoub Odeh,<sup>608</sup> Ayman Nasser,<sup>609</sup> Mahmoud Jeddah,<sup>610</sup> Bashir al-Khairi,<sup>611</sup> Dawoud Darawi,<sup>612</sup> Mahmoud Al-Safadi<sup>613</sup> and Anas Barghouthi<sup>614</sup>) are also PFLP members.

Furthermore, Addameer's former accountant Samer Arbid<sup>615</sup> was arrested in September 2019 for planning the PFLP terror attack in which 17-year-old Rina Shnerb was murdered.<sup>616</sup> Arbid was held in administrative detention many times for his involvement with the PFLP.<sup>617</sup>

Moreover, in December 2019, Al-Dameer, ICHR, PNGO and the Prisoners Committee of the Palestinian National and Islamic Forces (PNIF) held a joint conference on the state and treatment of Palestinian prisoners and detainees.<sup>618</sup> PNIF is also a member

of the Palestinian BDS National Committee (BNC),<sup>619</sup> the coordinating body for the BDS Movement worldwide.<sup>620</sup> PNIF was founded by Yasser Arafat and is composed of five US-designated terrorist organizations:<sup>621</sup> Hamas, the PFLP, the Popular Front for the Liberation of Palestine – General Command (PFLP-GC), the Palestine Liberation Front (PLF), and Palestinian Islamic Jihad (PIJ).<sup>622</sup> In addition, members of PNIF include Khaled al-Batsh, a senior member of PIJ,<sup>623</sup> Jamil Mezher, a member of the political bureau of the PFLP,<sup>624</sup> Mouin Oukal, a senior Hamas leader,<sup>625</sup> and Wasel Abu Yousef, secretary-general of the PLF.<sup>626</sup>

In 2017, Al-Dameer condemned the arrest and detention of Khalida Jarrar,<sup>627</sup> a senior member of the PFLP<sup>628</sup> and its representative in the Palestinian Legislative

Council.<sup>629</sup> Jarrar is a former vice-chairperson, director<sup>630</sup> and board member of Addameer and was so until 2017.<sup>631</sup> In 2018, Al-Dameer also condemned the arrest of Salah Hammouri, Addameer field researcher, who was arrested in 2005 for his involvement with a PFLP terrorist cell that planned to assassinate Israel's former Chief Rabbi Ovadia Yosef.<sup>632</sup>

### **Financials & Registration**

Al-Dameer is not financially transparent and only ever published its list of donors in 2005-2007.<sup>633</sup> Beyond this, the organization does not provide any financial statements or annual income reports.

According to its website, up until 2007, Al-Dameer received donations through wire transfer to its account in Cairo Amman Bank (0250071371300).634

In recent years, the organization has received donations from government entities such as the Swedish Consulate,<sup>635</sup> Norwegian People's Aid,<sup>636</sup> the United States Agency for International Development – USAID (\$394,500 in 2009-2017)<sup>637</sup> and the joint donor program of Denmark, the Netherlands, Sweden and Switzerland, also known as the Human Rights and International Humanitarian Law Secretariat (\$366,700 in the years 2014-2017).<sup>638</sup> Another key donor to Al-Dameer is the European Union, which sponsors many of the organization's publications<sup>639</sup> and events.<sup>640</sup>

In addition, the organization received donations from US-based foundations such as the Ford Foundation<sup>641</sup> and the National Endowment for Democracy.<sup>642</sup>

### **Conclusions**

As a Palestinian NGO located in the Gaza Strip, Al-Dameer plays a leading role in lawfare campaigns against the State of Israel. Its activities involve the collection of documents and evidence intended to incriminate Israeli policies in the Gaza Strip. It also collaborates with other Palestinian legal organizations such as PCHR, Al-Haq and Al Mezan. The evidence it compiles is often submitted to international judicial bodies, such as the ICC. To date, these four NGOs have submitted six reports to the ICC. In December 2019, the ICC Chief Prosecutor announced her conclusion that there are solid grounds to investigate Israel for committing "war crimes" in the West Bank and Gaza. While it cannot be stated conclusively that Al-Dameer was responsible for bringing about this decision, it is reasonable to assume that the organization, together with the other NGO mentioned, contributed to the evidence collection process that led to the ICC prosecutor's conclusion.

Despite Al-Dameer's staff hold alarming ties to designated terror groups, and the fact that the organization has shown public support for terrorists, it continues to receive substantial funding from governments and government entities such as the European Union, the Sweden Consulate, Norwegian People's Aid, USAID and the Human Rights and International Humanitarian Law Secretariat.
